Over the next year, the Colquitt County
School District will embark on renewing its
accreditation credential with COGNIA.
COGNIA has updated the performance standards
by which they support a school system's
improvement over time through a peer review process.

LEADERSHIP FOR LEARNING - WHAT IT MEANS

The ability of a leader to provide guidance and support for learning is a crucial attribute of a good institution. When leaders actively engage in their own learning while simultaneously supporting learners and teachers, they have a significant positive impact on the success of others. Leaders must consistently communicate their learning expectations to all teachers and learners with purpose and consistency. These expectations should be embedded in the culture of the institution and reflected by the behaviors and attitudes of all involved parties toward learning.

- STANDARD 7 Leaders guide professional staff members in the continuous improvement process focused on learners' experiences and needs.
- STANDARD 8 The governing authority demonstrates a commitment to learners by collaborating with leaders to uphold the institution's priorities and to drive continuous improvement
- STANDARD 9 Leaders cultivate effective individual and collective leadership among stakeholders.
- STANDARD 10 Leaders demonstrate expertise in recruiting, supervising, and evaluating professional staff members to optimize learning.
- STANDARD 11 Leaders create and maintain institutional structures and processes that support learners and staff members in both stable and changing environments.
- STANDARD 12 Professional staff members implement curriculum and instruction that are aligned for relevancy, inclusion, and effectiveness.
- STANDARD 13 Qualified personnel instruct and assist learners and each other in support of the institution's mission, purpose, and beliefs.
- STANDARD 14 Curriculum and instruction are augmented by reliable information resources and materials that advance learning and support learners' personal interests.
- STANDARD 15 Learners' needs drive the equitable allocation and management of human, material, digital, and fiscal resources

COLQUITT COUNTY SCHOOL DISTRICT IRB (INSTITUTIONAL REVIEW BOARD) APPROVAL PROCESS

As employees engage in graduate work toward a master's, specialist's, or doctoral degree, their university may require the school district to approve action research ventures that will involve employees and/or students of the district.

The IRB process protects the rights and welfare of human research subjects recruited to participate in research activities.

Graduate students (employees or external) may begin the approval process by contacting the Assistant Superintendent of Curriculum and Instruction (Marni, Kirkland@colquitt.k12.ga.us) and sharing the nature of the research and the timeline of the project. After review and approval of the initial application by the superintendent's cabinet, the applicant will be contacted, and any letters of support or forms required to complete the IRB process for the university will be completed by the Curriculum & Instruction Department.
