- Stress attendance. If your child is ill, home is the best place; otherwise, your child needs to take advantage of every school day.
- Be punctual (on time). The instructional day begins at 7:40 AM.

- Keep the lines of communication open between yourself and your child's teacher. Inform the teacher of any family situation that could influence your child's behavior. Also, if he/she is reluctant to come to school, let the teacher know so that together you can find the reason.
- Take your child to the library to get a library card and encourage reading for pleasure.
- Read to your child and with your child DAILY.
- Work at home with skills taught at school.
- Encourage your child to do his/her best every day at school.

In the classroom, teachers will:

- Provide parents with activities related to lexiles, math problems, and fluency to impact their child's overall literacy and math understanding. Parents will also learn about comprehension strategies and activities they can do at home to increase the child's Lexile level and math scores.
- Provide parent workshops/activities on a variety of reading, math, and science strategies to use with their child.
- Provide parent access to the reading and math programs utilized at school to show them how to access the program at home.

Families

At home, parents will:

- Implement the strategies provided by the teachers, aiding their child's reading comprehension and math understanding at home.
- Attend parent nights and use the strategies to help develop my child's reading comprehension at home as well as assist in helping choose the appropriate books within their reading level range and spend at least 15 minutes a day reading with/to my child. Math facts and strategies need to be implemented as well.
- Attend parent nights to learn about the reading and math programs available at school and that can be accessed at home, allowing their child to practice their reading skills at home.

Students

As a student, I will:

- Take home my weekly folder so that my parents can help me practice the strategies at home.
- Work with my parents to use the reading comprehension strategies and math strategies from the parent workshop/academies to help me develop my reading comprehension skills and math skills so that I can better understand learning in the classroom.
- Work with my parents to practice my reading and math skills at home or after school programs to enhance my comprehension score, lexile level and math scores.

Parents and visitors are welcome to visit our school. However, we do not allow instructional time to be interrupted for visits unless approved by administration. If parents need to meet with a teacher, please set up a meeting during teacher planning times. For other scheduled visits, please contact the principal and/or teacher in advance to arrange a time and date to visit. All visitors to the school must always wear a visitor's pass while in the building and/or on the school campus and must be appropriately dressed.

ACADEMICS

Organization of Instruction

In elementary school, students are placed heterogeneously in classrooms for most of the day. Within the classroom, students are assigned to flexible reading and math groups. Students have opportunities to work in flexible group structures, such as cooperative groups, whole class, individual, interest groups, or other criteria as determined by the teacher. Students are regularly evaluated and instructed at their appropriate instructional levels.

1. Grading Guidelines

Stringfellow Elementary will follow the Board Policy IHA: Grading Systems. To learn more about the K-12 Grading and Reporting Guidelines go on the Colquitt County District Website for further clarification. These grading guidelines can be reviewed with your child's teacher.

2. Retention & Promotion Policy:

Each teacher shall be responsible for determining through a variety of assessments whether a student appears to be on grade level or achieving at a level which, with accelerated, differentiated, or additional instruction or interventions, would allow the student to perform at grade level by the conclusion of the subsequent school year. Where the teacher believes the student is not performing at such a level, the teacher must implement remediation efforts as set forth in regulations or procedures. Parents will be informed of promotion and retention requirements in the student handbook or in other information disseminated to parents. A school-level team will review a student's performance prior to any decision to retain the student. Prior to a student's retention, the student's parents must be notified of the possibility of retention and given the opportunity to attend a meeting to discuss the matter. School-level promotion and retention decisions may be appealed to the Superintendent or designee. The Superintendent's decision shall be final.

3. Report Cards

When a teacher sends papers home to be signed, please look at the work. Your signature will let us know that you are aware of the work your child is doing. YOUR SIGNATURE DOES NOT MEAN THAT YOU APPROVE OR DISAPPROVE.

 Honor Roll Students in grades 3 – 5 are eligible for honor roll if their grades are 85 and above.

ARRIVAL AT SCHOOL

Doors will open at 7:00 a.m. All students will report the cafeteria for breakfast as they enter school through the side door each morning. Adults are on duty in the lunchroom. If your child will be having breakfast at school we ask that he/she arrive no later than 7:30 a.m. This will ensure that the student has enough time to eat and get to his/her class before the tardy bell rings. **Please do not drop your child off before 7:00 each morning.** We do not have any staff members on duty before 7:00am and dropping them off before this time creates safety concerns. Parents/guardians will be contacted by the social worker if this occurs.

ATTENDANCE- <mark>See the Colquitt County policies & procedures set forth by the district on the Colquitt </mark> County School website.

Parents must exercise reasonable diligence in getting their child to school. Frequent absences can contribute to difficulties in learning and create emotional strain for the students.

Attendance Protocol-Each student is to submit written documentation following days absent. (Parent or Doctor Note) Additionally, it is important that your child ask for any missed work following an absence. Valuable minutes of instructional time are missed each time your child is tardy or absent. We are committed to providing the best education possible for your child. Regrettably, this process is adversely affected by poor attendance and causes your student to fall behind academically. We believe that a strong partnership between home and school is essential in the education of children.

We know that you care and are concerned about your child's success in school, and it is our goal to help in

resolving this problem. If you have any questions, please contact the school Social Worker. The school social worker will contact parents regarding attendance.

Colquitt County Board of Education Protocol for Attendance is as follows:

- 1. Five (5) unexcused days School based Hearing.
- 2. Seven (7) unexcused days Hearing with School Officials, District Attorney Representative, and Department of Family and Children Services.
- 3. Ten (10) unexcused days Refer to DFCS.
- 4. Twelve (12) unexcused days possible legal action.

Absences – Students who are absent from school must bring in an excuse stating the reason for absences **within three days of the absence**. Students who arrive after 11:00 are considered a full day absent. If a student is absent from school, parents should send the following on a written note:

The date(s) of the absence; The reason for the absence; The parent's or guardian's signature; and, The parent/guardian phone number

Early Dismissal of Students –Students who leave school before 2:00 must be checked out in the office by a parent or guardian listed in our school information system. Any other person checking the student out must have a note from the parent or the parent must call. For others who bring in notes, the parent will be called before the student is released. **IF SOMEONE OTHER THAN THE PARENT IS PICKING THE CHILD UP EARLY, THEY SHOULD BE TOLD IN ADVANCE TO BRING A FORM OF PICTURE ID.** Parents who need to pick up their children early will need to do so **by or before 2:00.** Students who are picked up early consistently will be counted as tardy and possibly
referred to the school social worker or an administrator. Teachers are expected to teach up to 2:25.
Students who are frequently checked out at the ending of the day causes their child to miss important
instruction.

General Attendance Information - Students are expected to attend school each day unless they are sick.

Tardy –Tardy refers to any student who arrives after 7:40. It is important that children come to school on time. When they arrive late, they not only interrupt the class, they miss out on making their lunch choice, directions, and important classroom instructions. We know that it's not always possible, but we encourage you to try to make appointments for your child after school hours. Excessive tardiness or leaving early can cause hardship on the student, inconvenience for both the teacher and classmates, and may result in the loss of recess for the late student to make up lost time. Excessive tardiness will result in an attendance conference with the principal and a possible referral to our social worker so that we can help find a solution to the problem. It is our hope that students, with the help of their parents, can make punctuality and good attendance a lifetime habit.

BIRTHDAYS

Please DO NOT send home made birthday treats to school with your child. Treats and snacks are regulated and some food items are restricted in schools based on the following guidelines approved by the Colquitt County Board of Education. Food items served to students at class parties or school functions will be commercially prepared and packaged. Nutritional labels will be available on all products served. **Homemade items will not be allowed at school functions during normal school hours.**

Parents are also discouraged from sending flowers or balloons to school for their child. Deliveries of this sort disrupt the learning process in the classroom. Flowers or balloons that do arrive will be kept in the office for the student to pick-up at the end of the day. Flowers or balloons are not allowed on school buses.

TRANSPORTATION PROCEDURES

BUS TRANSPORTATION

Student and driver safety is our main priority on the bus. Students must ride the bus assigned to them unless a parent sends a note to school for the driver stating that the student will be riding home with another student on a different bus. Students must also be able to hold any item carried onto the bus in his/her lap. The bus driver is responsible for maintaining appropriate student behavior. Bus transportation is a privilege that may be withdrawn for inappropriate behavior. Abuse of this privilege will result in a disciplinary report that will be submitted to the principal for disciplinary action. A copy of the discipline referral will be sent to the parents. If the problem persists (continues), the principal may suspend the child from the bus. See the Colquitt County policies & procedures set forth by the district on the Colquitt County School website.

CAR RIDERS PROCEDURES

Morning

Students should be dropped off on the sidewalk where the school monitor is waiting starting at 7:00 AM and no later than 7:35 AM. The sidewalk intersects with another sidewalk leading to the lunchroom. Drivers should follow the single line of traffic ONLY beside the sidewalk. Please do not stop your car in this area to go inside the building. If you need to go inside, please park in a parking space, then walk inside, and stop at the front desk for help. Students who arrive after 7:40 must be signed in by an adult. If a child is not brought in by an adult when they are late, the School Social Worker will be contacting the parent/guardian of the child.

Afternoon

We ask the adults to **REMAIN in their vehicle** as children are escorted to you. We have monitors on duty that will make sure that the car pick-up line moves smoothly. Please remain in the line and move forward as the line moves. Please be attentive and try to refrain from cell phone use so that you are aware and using safe procedures. Each student that is picked up by car pick up will have a name sign. Name signs are to be placed in the window dash area so it is visible to the duty staff to recognize the name of the student(s) being picked up. If you do not have a sign, drivers will be asked to park and come inside to pick up the student.

CELL PHONES/ELECTRONICS

Students may have these devices at school, but they must remain powered off and left in their bookbag. If electronic devices are found out at school, the devices will be taken and held for a parent/guardian. We are not responsible for any devices that are lost or stolen at school. See the Colquitt County policies & procedures set forth by the district on the Colquitt County School website.

CHANGE OF ADDRESS, TELEPHONE NUMBER, OR EMPLOYMENT

It is extremely important that every student maintain an up to date address and working phone number on file in the school office. Please contact the school immediately when information changes. It is imperative that we know how to reach you in case an emergency arises. The school clerk will be asking for address information, contact information, etc, to ensure we have the most up to date information for our parent/guardians.

STRINGFELLOW ELEMENTARY POSITIVE BEHAVIOR INTERVENTIONS AND SUPPORTS

One of the foremost advances in school-wide discipline is the emphasis on school-wide systems of support that include proactive strategies for defining, teaching, and supporting appropriate student behaviors to create **positive** school environments. Instead of using a piecemeal approach of individual behavioral management plans, a continuum of positive behavior support for all students within a school is implemented in areas including the classroom and non-classroom settings (such as hallways, buses, and restrooms). Positive behavior support is an application of a behaviorally-based systems approach to enhance the capacity of schools, families, and communities to design effective environments that improve the link between research-validated practices and the environments in which teaching and learning occurs. Attention is focused on creating and sustaining primary **(school-wide)**, secondary **(classroom)**, and tertiary **(individual)** systems of support that improve lifestyle results (personal, health, social, family, work, recreation) for all children and youth by making targeted behaviors less effective, efficient, and relevant, and desired behavior more functional.

School Wide Discipline Policy

Class time belongs to the students. Teachers are expected to devote full attention to teaching during class and cannot complete this with constant disruptions.

The faculty and administration at Stringfellow Elementary School believe that school is a place for learning and building friendships. Some children enjoy coming to school because every day is a new experience. Students feel good about themselves when they participate in making school a good place to be.

Stringfellow Elementary is a bucket filling school! Have you filled a bucket today? The book, "Have You Filled a Bucket Today?" explains to children that we all carry an invisible bucket in which we keep our feelings about ourselves. When our bucket is full, we are happy; when our bucket is empty, we are sad. It teaches children how they can fill their bucket by loving others, helping others, and being a friend to others. It's important to know that when we fill someone else's bucket, we fill our own, and when we "dip" in someone else's bucket, we dip in our own bucket, too. This is a lifelong message and one that can easily spill out into students' homes and community.

Students are expected to follow the Number One Rule at Stringfellow Elementary: "Do the right thing, even when no one is looking." We celebrate good choices at all times and in all places (classrooms, hallways, cafeteria, playground, school buses). No student will be allowed to interfere with or repeatedly disrupt the educational process of others. Four major expectations govern the behavior of students at Stringfellow:

Be Respectful Be Responsible Be Safe BEE GREAT!

Each student at Stringfellow Elementary School has the right to a free and appropriate education; to be treated with respect; an equal educational opportunity and freedom from discrimination. Rights also bring responsibilities and a student is responsible for the manner in which his/her individual rights are exercised. The biggest responsibility is to exercise respect.

All inappropriate behaviors will be treated the same throughout the school. Every child will have opportunities to correct their behavior **<u>before</u>** the administration becomes involved. The stages are as follow:

Classroom Discipline Cycle for Minor Behaviors (Reminder 1-3 equals 1 cycle)

Reminder 1: A non-verbal warning- no words are said to the student.

Reminder 2: Verbal warning- Positively remind students what you want to see by saying to others around him or her (Thank you for getting to work).

- 1. Teacher will **talk** to the student to find out why they are doing what they are doing and put in a solution for the problem if possible. Teacher can seek help from the behavior team, social worker, admin, parent or counselor as needed. If no reason is given or problem is a choice proceed to step 2.
- 2. Teacher will say the following statement to the student who is doing the minor behavior: "If you choose to continue you choose "
- 3. Let them know the next infraction will result in a consequence

Reminder 3: Consequence Menu- Teachers need to come up with a menu of classroom consequences.

- 1. Teachers should post these in the classroom under the statement in Reminder 2.
- 2. A reflection sheet is to be completed every time you get to reminder 3.

The teacher will complete reminders 1 through 3 three times. On the fourth time, an office referral will be completed and sent to the office. The "try 3" documentation will be sent with the office referral. Below are the steps administered at the office level:

1st Office Visit:	Brief conference with administration – Parent notified
2nd Office Visit:	A period of time spent in the Opportunity Room (ISS) – Parent called
3rd Office Visit:	Office detail-parent, teacher, administration, and student meets for conference.
4th Office Visit:	At the discretion of the administration – possible corporal punishment,
	opportunity Room (ISS) or suspension

**Discipline steps are subject to change based on the Colquitt County Code of Conduct. Unfortunately, there are instances where the student may bypass the classroom consequences altogether. See the Colquitt County policies & procedures set forth by the district on the Colquitt County School website.

****Only the administrators (principal, assistant principal) may suspend or administer corporal punishment and we will follow established guidelines for both instances. These means will be used as a last resort only and after all other options have been exhausted. ***

ITEMS NOT ALLOWED AT STRINGFELLOW ELEMENTARY

- Roller/skate shoes
- CD players, MP3 players, IPODS, Nintendo DS all electronic games
- Lighters and matches
- Any item that might be considered a weapon (fireworks, plastic guns/knives, real guns/knives, etc.)
- Hat/caps are not be worn inside the building unless approved by the administration, a spirt day, fundraiser, etc
- Cell phones
- Sunglasses (except on field day or an assigned school spirit day)

****<u>Only</u> depending on if it is an incentive day or a planned/special day, students will be allowed to wear hats, sunglasses, or bring technology at the discretion of the administration. ***

BACKGROUND CHECKS

All school volunteers or parents/volunteers attending a school field trip as a chaperone MUST have a background check on file with the Human Resources Department at the Colquitt County Schools District Office. For more information, please call or visit the front office.

CONCERNS

Any person who feels concerned about any matter connected with Stringfellow Elementary should first contact the appropriate teacher, staff member, or principal. If the concern cannot be resolved contact the Student Services Director (Dr. Irma Townsend). The number to the central office, Board of Education is 229-890-6200.

CONFERENCE OPPORTUNITIES

School-wide conferences are held at scheduled times throughout the school year. Watch for notes being sent home. However, if you wish to have a conference with our child's teacher at any other time, please call to make an appointment or send a note to your child's teacher requesting a time. The teacher's schedule does not allow for drop-in conferences. Teachers may be contacted by email, note or telephone. If you call during the school day, the office will leave a note to have the teacher return your call or forward you to the teacher's voicemail.

DRESS CODES

During the school day, the primary focus of the student should be to learn. Some clothes that are suitable for wear outside of school are not suitable for wear at school. The age and gender of the child and what is considered to be developmentally appropriate will be considered in the enforcement of the dress code. The administration reserves the right to amend or modify the dress code to ensure safety or improve the atmosphere for learning.

- 1. No bare midriffs, tank tops, halter tops (one shoulder out, tube tops) no low or plunging necklines, spaghetti straps, loose fitting sleeveless tops that do not cover foundation garments.
- 2. ALL length of shirts for girls should cover the stomach area.
- 3. No sagging pants or shorts, no low waist pants, low rider pants, pants/shorts with holes.
- 4. No overly short dresses or shorts (must come to the fingertip of the <u>middle finger</u> when the arms are down at the student's side.)
- 5. Earrings are to be worn only in the ears.
- 6. Clothing depicting disruptive words, gang related activity, violence, vulgarity, drugs, alcohol, or disrespect for others will not be allowed.

- 7. Hats, hoodies, scarves, headbands, doo-rags, bandanas, or other head coverings are not allowed unless approved and granted permission by the administration. Certain situations and circumstances will be addressed and dealt with on a case-by-case basis.
- 8. Students are expected to wear appropriate footwear for all school activities.
- 9. Haircuts/designs that symbolize gang related activity or that disrupt the learning environment are not allowed.

PARENT DRESS

- <u>All parents and adults visiting the campus should physically appear in a manner appropriate for our educational learning environment</u>. Adults should follow the same guidelines that are expected of <u>students</u>. Do not wear sleep attire or clothing that exposes undergarments or private body parts. Low-cut tops, and extremely short skirts or shorts are not appropriate for the school environment. Clothing that advertises alcohol or drugs is not allowed on campus. Any parent dressed inappropriately may be asked to leave campus. Help us maintain our respectful student standards by modeling Stringfellow Elementary School's expectations.
- 2. All guidelines are subject to the interpretation of the administration.

Dress Code – Procedures for Violations

The administrators have the final decision as to the appropriateness of all clothing. Students who dress inappropriately will be sent to the office and asked to change or be provided with appropriate clothing, if possible. Parents will be contacted if they need to bring clothes to the student. Parents are an important part of our school dress code and will be informed if a student is repeatedly in violation of the dress code.

FAST FOOD

We provide healthy, nutritionally balanced lunches at school. Fast food is not allowed in the cafeteria at lunchtime. For more information regarding this, see the administration.

EMERGENCY MEDICAL FORM

All medication to be administered at school by the nurse requires the signed authorization of the parents. It is very important that parents complete this form and send it back to school as soon as possible. Any questions about the administering of medication at school, please see the school nurse in person.

EMERGENCY PREPARDNESS

We have drills that are practiced periodically during the school year. All students are informed and practice escape routes. NO TALKING is permitted during these drills.

- Fire Drills: Fire drills are held once a month so staff and students will be trained in fire emergency procedures.
- Tornado Drills: Tornado drills are held at least twice a year so staff and students will be trained in tornado emergency procedures.
- Emergency Lock-Down: Emergency lock-down drills are held to ensure that students and staff know what to do in case of an emergency lock down.

FIELD DAY

Field Day is held each year in the spring. All students participate in athletic events. All parents are asked to purchase a t-shirt for their child/children for this event. Parents are invited to attend.

FIELD TRIPS

First-hand learning experiences are encouraged at all grade levels. Classes take several trips during the year. These trips are part of the instructional program. One permission form for local trips must be signed at the beginning of the year. Each out of town trip requires an additional form. Parent are invited to participate in Field Trips but must provide their own transportation based on Colquitt County Schools policy.

HOMEWORK

Homework provides an opportunity for parents to become partners in their students learning process. Teachers give light homework to strengthen children's skills in specific areas. Students will be assigned reading each night, serving as part of their homework. All students in grades Kindergarten-5th grade will be assigned homework throughout the year. It is not taken for a grade. See the Board Policy IHA: Grading Systems to learn more about the K-12 Grading and Reporting Guidelines on the Colquitt County District Website for further clarification.

LEGAL CUSTODY

If there are any custody arrangements existing regarding your child, the school must have a copy of the official court documents. These documents must be updated yearly or as specifics change. Stringfellow Elementary School does not get involved in legal custody battles between parents, guardians, etc. If legal custody issues arise, the administration will contact central office and speak with Dr. Irma Townsend, Assistant Superintendent of Student Services about this issue and further guidance.

LOST AND FOUND

Found items are kept in or near the school office. Found items that are identified with the child's name will be returned. With this in mind, please remember to label your child's clothing. Items not claimed in a reasonable amount of time will be given to a charitable organization at the end of the school year.

MEDICAL CONCERNS-Updated June 2018

It is imperative that all school personnel know of any type of allergy that your child has, such as bee stings, food, etc. This information should be provided on the health form that is sent home with your child. The nurse will keep these forms. She will see to it that the appropriate personnel are notified. The nurse will also call you in the case of an illness.

NOTES REQUIRED FROM PARENTS/GUARDIANS

The school requires a note from parents or guardians under the following circumstances:

- To explain an absence
- To explain a tardy (late)
- To request early dismissal
- To excuse a child from recess or physical education (doctor's excuse required)
- To change daily transportation procedures (how the student goes home)

The school social worker will file these notes. The school social worker will work with the school clerk to get this information.

OUT OF ZONE

If you live out of the Stringfellow's district school zone, it is the responsibility of the parent/guardian to ensure that their child is brought to school on time and picked up on time. If this becomes an issue, the administration reserves the right to ask you to go enroll in your zoned school based on your address.

PARENT INVOLVEMENT

Stringfellow Elementary values and actively seeks parent involvement to support student success and achievement. We believe that the support and input of parents is essential to the successful implementation of all state and federal categorical programs. Stringfellow School, in consultation with parents and teachers, has developed a policy on parent involvement and the Home-School compact that outlines the responsibilities of students, parents, teachers and administrators in ensuring student success. All parents are invited to provide input and to support the compact so that our children have access to the best educational opportunities provided during the year. Involved parents are essential to improved student achievement. Stringfellow Elementary fosters and supports active parental involvement by:

If parents plan to bring in items for birthday celebrations, they must first make arrangements with the teacher and then those items cannot be brought in before 2:00. All food items served must meet the following guidelines approved by the Colquitt County Board of Education.

(a) Food items served to students at class parties or school functions will be commercially prepared and packaged. Nutritional labels will be available on all products served. Homemade items will not be allowed at school functions during normal school hours.

RESPONSIBILITIES OF STUDENTS-Student Behavior Code

The Student Code of Rights, Responsibility, and Conduct assumes that the vast majority of Stringfellow students are law abiding and respect both public and personal property, as well as the rights of others. However, when student conduct disturbs the learning environment or threatens the health, safety, and welfare of themselves and of others, they subject themselves to disciplinary action. LOCAL SCHOOL GOVERNANCE TEAM

The Stringfellow Elementary Local School Governance Team was established to help the Board of Education develop and nurture participation, bring parents and the community together with teachers and school administrators to create a better understanding of and mutual respect for each other's concerns and share ideas for school improvement.

SCHOOL NUTRITION/CAFETERIA INFORMATION

ALL Colquitt County Schools Participate in the Community Eligibility Program. ALL Colquitt County School students are eligible to receive a healthy breakfast and lunch meal at <u>NO CHARGE</u> each day of the school year. No additional action is required of you. Your child(ren) will be able to participate in this meal program without having to pay a fee or submit an application. SEXUAL HARRASSMENT and BULLYING

Sexual harassment and bullying are forms of discrimination prohibited by federal and state laws. Consistent with these laws, harassment and/or bullying of students is prohibited. Any student that feels he or she has been subjected to harassment and/or bullying is encouraged to talk with an adult at the school immediately. TELEPHONES/CELL PHONES

Telephones in the school are for business purposes. In emergencies only, students may obtain permission to use the phone. We will allow students to call when they have forgotten something at home or to make arrangements to visit another child after school. The staff of Stringfellow Elementary greatly value their instructional time. If you need to leave a message for your child's teacher, you will be connected to his/her voice mail. Students will only be called from the classroom in case of an emergency.

VALUABLE PROPERTY/PERSONAL ITEMS

It is recommended that sports equipment, playground games, and toys from home not be brought to school. The school takes no responsibility for their loss or damage.

No electronic devices, CD players, MP3 players, cameras, video games, laser pointers, cell phones, trading cards or toys are allowed at school without the permission from the administration for a specific reason and a limited time.

WITHDRAWAL OF STUDENTS

If you find it necessary to change schools during the year, please notify the office as soon as possible. It is helpful if you can provide the address of the new school (if it is not in Colquitt County) and your family's forwarding address. Your child's records will be sent within ten days of our receiving a request for records from the new school (less if the school is in Colquitt County).
