





- IV. Financial/Resource Allocation: Finances are good.
- V. Curriculum: Ms. Harrison would like for students like for students to take the GMAS as a practice. If parents would like to opt out, parents should write a letter to Ms. Harrison that they would like to opt out. Students that come to school and opt out will be housed in the media center doing a standards based packet. Students' phones will be taken up by staff during this time. The school would like for all students to take the test to see how students are performing. The test will show gaps to assist in preparation for instruction for upcoming years. May 10 starts 7th grade testing and May 17 for 6th grade. Mr. Horne commented on the advantages of having the GMAS at the end of the year. Registration information was sent home to 6th graders for connections classes for 7th grade. 5th grade information will be sent out soon. Packer X and Stem team will be an option which are application based.
- VI. Achievement of School Improvement Goals. Before spring break the SIP was reviewed. No changes were made. Administration says we are on track to meet goals.
